Article 1. BOOKING CONDITIONS

These conditions apply to all bookings accepted by Ultimate Racing UK Ltd unless otherwise agreed in writing. Your booking is not confirmed unless payment is made in full.

1.1 The company gives no Warranty about the event to which the hospitality is sold as to its quality, suitability or otherwise.

Article 2. EVENT SPECIFICATION

The company will supply the hospitality package or event management services detailed in the event specification (see package details). The event specification may be varied with the company's written agreement.

Article 3. PRICE

The total price payable for the hospitality package (see package details) consists of:

- (a) a deposit of 50% of the total price payable with your booking, and which is non-refundable,
